PRESENTATIONS	<ul style="list-style-type: none"> ✚ <u>Maryann Davis, PhD, Director of the RTC, Marsha Ellison, PhD, and John Delman, MPH, Executive Director, Consumer Quality Initiatives, Inc.</u> gave a joint presentation on the Transitions RTC. The RTC is supported by a five year grant funded by NIDRR and SAMHSA and funding from Commonwealth Medicine. The overall aim of the RTC supports the successful completion of schooling and training and movement into rewarding work lives in the 14-30 year age group population with serious mental health issues. The RTC conducts research that tests and informs interventions that support education, training and working during the transition to adult. The field has been greatly impacted by the research findings which also serve to continually motivate the dedicated staff. Marsha Ellison invited feedback and questions. For more complete information, A PDF copy of the entire presentation is attached. ✚ <u>Matilde Castiel, MD and Lisa Fortuna, MD, MPH</u> gave an update on the Hector Reyes House (HRH) which opened its doors two years ago. The home is named after Hector Reyes who saw a problem in the Worcester community and had a vision as to how to improve the care for those in the Latino community to achieve improved health outcomes and enhance quality of life. The HRH offers culturally sensitive treatment designed to reflect the Latino culture and includes integrated case-management components as well as on-site medical and psychiatric services. Substance abuse affects the Latino population disproportionately with an insufficient residential accommodation for those seeking transitional services. Dr. Castiel announced that they have just purchased a second house to do transitional housing which will allow for continued recovery support, employment readiness, and treatment. It is hoped that there will be future UMASS collaborations for research and training. Following the presentation, Dr. Fortuna introduced Danny Rodrigues who shared his story and experience at the HRH. He hopes that sharing his personal experience will provide

These programs fund projects focused on the development or expansion of global health training or research projects. Two types of grant awards are available</p> <p>Pilot grant awards: Pilot project grants will catalyze the development of translational research projects that provide a firm scientific basis for clinical practice and public health policy in global settings. These grants may be used to establish the clinical and laboratory infrastructure to support medical/nursing education and translational research and/or to develop specific translational research projects. Faculty investigators from all UMMS departments and programs are encouraged to submit proposals. Projects that are innovative, interdisciplinary, involve multiple investigators at UMMS and/or other UMass campuses, capitalize on UMMS programmatic strengths, and that have the best potential for future growth and external funding will be prioritized for funding.</p> <p>Travel awards: Travel grant programs will facilitate the training of global health researchers and care providers, the establishment of training or research programs, or the conduct of research.
