We are medical and pharmacy students working with the Quaboag Hills Substance Use Alliance to examine how teen vaping is being addressed in clinics, schools, and local government.



Where is the Quaboag Hills Region?




Region spans the most rural areas of Hampden, Hampshire, and Franklin Counties



Current Related Advocacy:

Ban Information and Impact

- Support from teen substance use advocates
- Opposition from retail owners
 - Loss of revenue and not reimbursed for inventory
- Impact on e-cigarette users
 - Teens report they're still able to get vapes
 - Some are going back to cigarettes
- Ban expires in January

"We know eating red meat every day is detrimental to your health, but when there is E.Coli H.157 in that same product I have to pull it from the shelf immediately. The same principal applies to tobacco products."

Massachusetts Vaping Product Ban

On September 24, 2019, Governor Baker declared a public health emergency in the Commonwealth due to severe lung disease associated with the use of e-cigarettes and vaping products and the epidemic of e-cigarette use among youth.

The Commissioner of Public Health has temporarily prohibited the sale and display of all vaping products and e-cigarettes until further notice.

Current Related Advocacy:

MA Legislation: Bills S.2357 and H.4089

Ban the sale of flavored tobacco products across the Commonwealth

Limit sale to adult only smoking bars (ex. hookah lounges)

Goal: Limit the power companies have to target young people with fruity and sweet flavors

PURCH Advocacy Pitch:

Key Takeaways

There are currently prevention efforts and programs for teens with diagnosed substance use disorders. Yet, for students who vape but do not have a diagnosed disorder, doctors, teachers, caregivers, legislators, and town advocates do not have the resources to support a primary intervention.

- Doctors "just don't have enough time" to dive into the issue if a student does not have an emergent substance use disorder (S. Siege, personal communication, 10/22).
- Teachers and caregivers feel "unprepared to have these conversations" and "just don't know appropriate resources" (Ware High School Teacher, personal communication, 10/28).
- Town advocates explain that government "refuses funding for a project that is not yet evidence-based" (N. Jenkins, personal communication, 10/25).

PURCH Advocacy Pitch:

Service Project for Primary Intervention

With the help of Quaboag Hills Substance Use Alliance leaders, Nekr Jenkins and Gail Gramarosa, we propose piloting a substance-free stress management group in schools to benefit adolescents who need assistance quitting vaping before a child develops a substance use disorder.

Please take action and consider funding a pilot study to:

- Allocate time of a trusted teacher to lead a support group of 5-10 students
- Compensate an expert to design curriculum and provide teacher training
- Provide transportation to allow for teens to access the support group on weekends in order to maintain anonymity
