Current-State

Assessment: Includes

Groundwork Questionnaires to be completed by each UMMHC entity followed by a Site Visit by the Epic Project Team and Epic staff to understand currentstate workflows to help guide future-state design.

Collaborative Design

Sessions: 500 sessions that will provide the opportunity for nearly 1,000 Subject Matter Experts from across UMass Memorial Health Care (UMMHC) to review the Epic foundation system and make decisions that will drive the configuration of Epic to best meet the needs of UMMHC.

EPIC DESIGN PARAMETERS

The Epic Executive Steering Committee is responsible for determining the 47 Epic Design Parameters (EDPs) that will guide the 500 Collaborative Design Sessions. The following EDPs have been approved so far by the committee:

- **EDP 1:** UMMHC will have systemwide, standardized order sets with personalization capability
- **EDP 2:** UMMHC will have a systemwide, standardized formulary
- **EDP 3:** UMMHC will have systemwide, standardized workflows and content across all facilities
- **EDP 4:** EDP 4: Leverage the Foundation System for clinical content and supplement with third-party vendors and/or existing UMMHC content. The following 2 of 5 decisions for EDP 4 have been approved.
 - Foundation system content will be used for electronic order set development
 - First Data Bank will be used for formulary content (e.g., allergens, medication dosing parameters)
- EDP 5: All providers/staff who will use Epic will be required to complete training and demonstrate proficiency to gain system access
- **EDP 6:** Entity leads will be responsible for monitoring success and profitability performance post-live.
- **EDP 7:** All applicable current and future Epic modules will be implemented at all applicable UMMHC entities.
- DEP 9: UMMHC will pursue HIMSS Analytics* Stage 6 within 60 days of go-live and pursue Stage 7 within 12 months post-live.

*Healthcare Information and Management Systems Society (HIMSS) Analytics is an industry advisory group that does market research across hospitals and ambulatory practices, to determine an organization's level of adoption and integration of their electronic health record system. There are seven stages, each with increasing capabilities and integration requirements.

Please note: EDP 8 regarding customer relationship management, is being further evaluated.
