






## **iSPARC Funding Sources FY 2022**


The investment that DMH makes in its funding of iSPARC as a Research Center of Excellence provides an impressive return on this investment to the Commonwealth.

Every \$1 invested by DMH in FY22 brought to UMass Chan and the Commonwealth a return of about \$9 in funding for our portfolio of research, training, technical assistance, and service delivery.









# **Stakeholder Engagement Program (SEP)**

- As-needed consultation provided to iSPARC investigators and research teams, tailoring advice and resources to the investigator's and study's goals, which has enhanced our investigators' capacities to do community-based participatory research
- 2. Stakeholder advisory boards
  - weSPARC insight –adults with lived experience of mental health conditions
  - Young Adult Advisory Board national board of 18-29 year olds with lived experience
  - Family Advisory Board family members of individuals with lived experience
- 3. Annual Assessment of Stakeholder Engagement system to assess the level of stakeholder engagement and participatory methods across all ongoing iSPARC research studies. SEP collates the findings for feedback and provide education on how to infuse stakeholder engagement throughout a study's life cycle.

## Law & Psychiatry

- 1. Risk Assessment in Juvenile Justice: A Guidebook for Implementation Produced and disseminated this first (and only) Guidebook on how to effectively implement risk/needs assessment and case planning in justice settings.
- 2. Massachusetts Youth Screening Inventory-2 (MAYSI-2) Developed, normed, and nationally normed this most widely used behavioral health screen in juvenile justice in the United States.
- MacArthur Competence Assessment Tool Criminal Adjudication & Juveniles Adjudicative Competence Instrument – These standardized instruments – one for adults and one for juveniles - improved the quality and procedures for competence to stand trial evaluations in the U.S..



### **Transitions to Adulthood Center for Research**

- 1. Multisystemic Therapy for Emerging Adults intervention to reduce antisocial behavior, and mental health and substance use disorder symptoms in 17-25 year olds. The only intervention to date with evidence of efficacy to reduce recidivism in young adults.
- 2. Healthy Transitions Initiative A SAMHSA-funded program that has provided grants to 25 states to improve services for transition-age youth with or at risk of serious mental health conditions. Our research provided the rationale for its launch in 2002 and additional funding of the program over time.
- 3. TEST- CTE Guide –guide to promoting Career and Technical Education (CTE) is one of a 3part set for practicing /implementing best practices in transition planning for secondary students with serious mental health conditions. Promoted in the Department of Labor-funded *Social Security Income Youth Solutions* as one of "Twelve Ideas to Promote Employment for Youth with Disabilities...".

### **DeafYES! Center for Deaf Empowerment and Recovery**

- 1. **Dr. Alexander Wilkins**, Co-Director of DeafYES, is currently on the path to achieving independence as a clinician-scientist to our knowledge, the first Deaf person in the nation to serve as a behavioral therapy clinical trials researcher.

## **Lifeline for Moms**

- 1. MCPAP for Moms is an internationally recognized statewide mental health service delivery approach that improves treatment rates and outcomes for perinatal mental health and substance use disorders. It has become a national model for perinatal mental health care, inspiring federal and state-level funding for additional Perinatal Psychiatry Access Programs across the US.
- 2. Lifeline for Moms National Network of Perinatal Psychiatry Access Programs There are now 24 funded and operational Perinatal Psychiatry Access Programs in 21 US states with the potential to cover nearly 54% of the 3.7 million US births each year, in addition to two programs available across the US and one Ottawa-based program.
- 3. The American College of Obstetricians and Gynecologists disseminates our practice-level approach for helping obstetric practices detect, assess, and treat perinatal mood and anxiety disorders.
