This may occur through decreasing barriers to accessing health services, providing an infrastructure conducive to effective health promotion programs, or directly increasing the resources and infrastructure of the public health system.	Major advocacy area: Reducing infant mortality rate Worcester Healthy Start Initiative aims at reducing infant mortality rates through providing comprehensive prenatal services. This program has been successful to date. Grant funding is up for renewal. It is important to renew this grant in order to continue the programs that have contributed to lowering the infant mortality rate.
